**Subject:** Schools Supplies info for 2022-23 - DEADLINE to order is June 15 (to avoid shipping charges)

Good evening Castle Park Families,

For the 2022-2023 school year we are doing a school organized bulk order for **Kindergarten and Grade 1 students** which will be paid through [www.schoolcashionline.ca](http://www.schoolcashionline.ca). We are going to collect the supply package fee of \$60 from our future Grade 1 students. **You will receive notification when the item is live online** starting next week - we would like to collect this by the **June 15<sup>th</sup> deadline**. Parents of Kindergarten students will pay in September through School Cash Online – more information will be provided when Kindergarten students are assigned to a class on Friday September 9<sup>th</sup>.

For **Grades 2-5 students** the Creative Packs School Supply Ordering process for next school year (2022-2023) is now up and running. The School Supply Packs will be available to purchase **“ONLINE only”** – please click on the link below to place your order. If you choose not to order your child’s school supplies through Creative Packs, attached you will find the Grades 2-5 School Supply Lists for shopping on your own. Part of the reason we use these packs is for consistency in the quality of supplies. Going out and buying from various vendors takes you time and effort while generally not saving as much money as hoped, especially with the price of gas. **The deadline for ordering Grade 2-5 packs is Wednesday, June 15** – after that there will be a delivery fee. Orders are scheduled to be delivered to our school by June 24<sup>th</sup> and will be sent home with your child before they leave for the summer break.

I have copied the Creative Packs information provided to us:

#### Ordering a pack

- Order your child’s pack from <https://creativepacks.ca/collections/packs/castle-park-elementary+>
- **Part A:** The essential pack with items chosen by your teacher/school. This comes as a package deal with all items listed included. Items cannot be changed or omitted.
- **IF there are Part B items:** You MUST have all Part B items. Individual Items are required by your teacher and to be ordered if you do not already have them.
- **IF there are Part C items,** they are optional.
- ***Part B and/or C items must be ordered at the SAME TIME as the Part A pack. You may not order Part B or C items at a later date.***

**Payment** - Payment types accepted are VISA & MasterCard, or prepaid VISA or prepaid MasterCard

#### Ordering Deadlines

- **Packs ordered by Wednesday, June 15<sup>th</sup> receive free shipping to the school.**
  - These will be distributed by your school to your child before the end of June 2022.
- Packs ordered after Tuesday, June 14<sup>th</sup> will pay a \$12.00 delivery charge and will be shipped to home.

### Receiving a Pack (for orders shipped to your school)

- Packs will be distributed by the school by the end of June.
