Wednesday, November 14th is the 24th annual "**Take Our Kids to Work Day**". This initiative occurs during National Career Week whereby several events will be taking place around the community in support of the theme.

On this day, hundreds of thousands of Grade 9 students will spend the day at workplaces across Canada. Students will experience a wide variety of job and career options including what it takes to be a paramedic, work on a makeshift assembly line, develop a mock sales presentation or work in the IT department for a large corporation.

This can be a valuable experience for your Gleneagle Grade 9 student and will also impact their career and world-of-work awareness. Career development and awareness is one of the key elements in the learning outcomes of the **Career Education 9** course, as mandated by the Ministry of Education.

We, at Gleneagle, are asking all parents/guardians to accept their Gleneagle Grade 9 student into your workplace for the day on **Wednesday, November 14**th. If a placement is not possible at your own work site, please check with another family member or family friend. **All students should be at a workplace for the day** so that they can report on their experiences through a Career Education 9 assignment. Parents/Guardians need to be aware that these students are not considered part of a formal work experience program, **so they are not covered by the Workers' Compensation Board**. They are no different than any young person visiting the workplace.

Students will be given an assignment to do while/after their workplace visit that will go towards their Career Education 9 mark. The possibilities of experiences open to students are exciting and vast – we look forward to some interesting reports from our students.
