STANDARDS OF CONDUCT FOR PARENTS AND GUARDIANS

The Board wishes to set out expectations for the conduct of for parents/guardians, when interacting with school district staff and while at school or school sponsored events. The Board believes that parents and guardians are role models and have a responsibility to respect the rights and dignity of others in school communities. Parents and guardians are responsible for contributing to a positive working and learning atmosphere in schools, on school grounds in the school community. Parents and guardians have an important and unique role in contributing to a school culture that enhances student learning and enables everyone in the school community to do their best work, do their best learning and develop in a safe, supportive and caring environment.

Specifically

- 1. The Board encourages the conduct of parents and guardians in the school community to be consistent with the high standards of conduct expected of staff and students. The Board expects that conduct to be based on respect for oneself, respect for others, and respect for the property of others. To help ensure that school communities are places where students will develop into responsible citizens, parents and guardians are expected to:
 - 1. Communicate and work cooperatively with others
 - 2. Respect the rights of all persons within the school community
 - 3. Respect the legitimate authority of the school staff

Student Matters and Section 11 of the School Act - Appeals.

- 4. Respect the school's physical school facilities
- 5. Respect the diversity of our school community
- Behave in a sale and responsible manner at all times and
 Not threaten, harass, bully, intimidate or assault, in any way, any person within the
- school community.

 2. The Board expects that parents respectfully engage in the process to resolve concerns as outlined in in Administrative Procedure 380 Resolution of Student or Parent School Concerns, and if required and appropriate, in the processes as indicated in Policy 13 Appeals Regarding
- 3. In accordance with Section 7 (2) of the British Columbia School Act: "A parent of a student of school age attending a school may, and at the request of a teacher, principal, vice principal or director of instruction must, consult with the teacher, principal, vice principal or director of instruction with respect to the student's educational program."
- 4. While attending school and school sponsored functions and activities, parents and guardians, shall be subject to the expectations of this Policy and shall not engage in any conduct which has the effect of negatively impacting the school environment, whether that conduct occurs on School District property, or at a school sponsored function or activity.

- 5. Serious breaches of the expected standard of conduct, especially those that threaten the safety and welfare of others in the school community will result in action by the school district to stop or limit the harm done by the parents or guardians responsible. These actions may after or limit the consultation and communication processes that are part of the role of parents and guardians. In some circumstances, this may involve invoking Section 177 of the School Act-Maintenance of Order (see Administrative Procedure 145 Issuance of No Trespass Order).
- 6. This Policy is not intended to limit the access of parents to resolve concerns as set out in Administrative Procedure 380 Resolution of Student or Parent School Concerns or appeal processes as indicated in Policy 13 Appeals Regarding Student Matters and Section 11 of the School Act Appeals.
