#### Hot Lunch discussion:

# 7. ADMINISTRATIVE REPORT

Covid 19:

Fraser Health will continue to only issue Covid 19 exposure letters to those parties that may be impacted, not the entire school community.

Registration & Focus:

We have approximately 458 students so far this year. The is focussed on connections this year – between staff, between staff & students, between students, etc. To increase the connection with the parent community, perhaps more photos can be distributed about what is happening at the school. A school newsletter might also be possible – if so, there may be opportunity for a "PAC Updates" section.

### PAC Budgetary Items:

The climbing apparatus on the playground has reached the end of its life, and is no longer safe to use. The school will be researching options to replace this equipment. As well, the school is considering establishing an Outdoor Classroom. When these options, and their costs, are determined, the PAC may wish to contribute funds to the projects. Additionally, the teachers' wish lists should come in around November for the PAC's consideration.

### Fundraising:

It was noted that any fundraising initiatives cannot be promoted on the KEV system, as there are parents whom have opted out of solicitation. However, we could do a straight-up donation drive through KEV. A point to consider in the future.

### Halloween:

Individual classrooms will be celebrating Halloween on Oct 29<sup>th</sup>. A notice regarding costumes will be sent out shortly.
