Dear Parents & Guardians,

The staff at Port Moody Secondary is getting ready to welcome students back to school in a safe and controlled manner. The Ministry of Education announced that BC schools will open in Stage 2 where students are encouraged to attend daily as schools will not be able to provide the remote learning options in the manner that we did last spring. On Tuesday, September 8th and Wednesday, September 9th all staff will be on site reviewing and implementing safety procedures within the school. The first day of school for students is Thursday, September 10th for orientation purposes and a schedule for the 10th and 11th will be sent home to families. You can read more here:

We have worked under the guidance of public health authorities and the Ministry of Education to develop a plan so that students and staff can learn and work together safely. We are ready to welcome your child back to school. We will strive to keep learning as the focus, but school *will* look different as health and safety are critical factors in our planning. Some of the many actions taken to safely restart school this September include:

Health and Safety

- Daily health screening check for students (by parents) and staff before arriving at school.
- Students who are ill (cold, flu or <u>showing Covid-19 symptoms</u>) must stay home. If a child becomes ill during the school day, they will be isolated from their Learning Group/class and the parents contacted to come and pick up as soon as possible.
- Families arriving from outside of Canada must self-isolate for 14 days before entering school.
- There will be enhanced cleaning protocols especially focused on high touch points (doorknobs, faucets, etc.)
- Teachers will be encouraged to take their class outside more frequently where appropriate.
- We may need to adopt a staggered schedule approach to promote physical distancing at drop off/pick up.
- There will be no large gatherings (assemblies, special events, open house) at this time.
- No sharing of food or drink.
- Parents and visitors must make an appointment to meet with staff. There will be limited access to the building by parents and visitors. All visitors must sign in for the purpose of contact tracing. Virtual meetings will be an option for staff and parents.

- We ask parents to practice physical distancing (staying apart 2m) and wear a mask when on school grounds. This is for your safety, the safety of staff and students, and is good modeling for our students.
- Masks are expected in hallways, common areas and where socially distancing measures outside of Learning Groups cannot be maintained. The only exception is for staff and students with a medical condition that precludes them from wearing a mask.
- All students will participate in a safety orientation during Week One (September 10th & 11th; further scheduling details will be sent out later next week).

Learning Groups

- A <u>Learning Group</u> is defined as a group of students and staff who remain together for an extended period of time and who interact primarily with each other.
 - In the Coquitlam School District, the Learning Group will be your student's classmates and any staff assigned to work with the students on a regular basis, like the class's teacher.
 - Within the learning group, there will be less emphasis on physical distancing, but physical contact is discouraged.
 - Secondary schools are being organized in quarters: Q1, Q2, Q3, Q4 (8-9 weeks in duration). We are currently revising our public calendar in relation to this shift.
 - The Ministry of Education has stated that Learning Groups cannot exceed 120 people at secondary school. In many instances, our learning groups will be significantly smaller.
 - A standard secondary student's schedule will have 2 courses per quarter. One course will take place in their Learning Group and the second will occur in a physically distanced environment twice per week and remotely for the remaining days of the week. Courses outside the Learning Group will be smaller in size.
 - If students interact with students or staff from other learning groups, they are to practice physical distancing and wear a mask. Staff such as specialist teachers and counsellors work across the school with individual students and/or learning groups and will wear a mask.

Educational Programming

- Our school will be focused on providing in-class instruction during Stage 2 as well as remote learning as assigned to each student's schedule.
- Student well-being will be guiding educators in planning and supporting the successful return of students to school.
- Electives will continue to be offered and will appear on students' quarterly schedules. Instruction and programming could look significantly different depending on the curricular area as we endeavor to meet health and safety guidelines.
- Students with disabilities/diverse abilities will continue to be supported by the goals outlined in their IEP.
- Regular health and safety practices (frequent hand washing) will be part of the educational program.

- Students will continue to receive report cards.
- Parents of children who are medically diagnosed as immunocompromised by a physician should contact me by Tuesday, September 1st. The following links are provided for your reference:

Schedules

We look forward to welcoming students back to school on either Thursday, September 10th or Friday September 11th. We will provide you with the time and day your child is to attend in a follow-up "Orientation" e-mail next week. At that time, we will also include general answers to start up questions such as lockers, athletics & clubs, when and how students will receive their schedules etc. On the 10th or 11th, students will attend a safety orientation session of approximately 60-75 minutes.

*Students will be provided with a mask and will be asked to wear it. If a student already has a mask, we ask that they wear it to the safety orientation.

Students will begin their classes on Monday September 14, 2020. Students will attend in block 1 (AM) and this will be their initial Learning Group Cohort. Please see above under 'Learning Groups' for additional information.

In past years, students received their timetable and would typically see 8 courses divided over two semesters. The quarterly system allows for those 8 courses to be experienced in a different routine and timeline than we are accustomed to. As a preview of how student schedules will run over the year please review the chart below.

In a quarter most students will participate in 2 classes minimum. Students registered in full year courses such as band, and additional electives such as leadership that run outside of the schedule, at lunch (period 3) and after school, will receive further clarification on when and how these courses will operate. Each quarter is approximately 44 school days in length.

*Within each quarter the 2 classes will flip at the mid point (approx. the 22nd day of instruction) for parity of daily in class instruction. In quarter 1 for example: the PM (2) class will move to be in session Monday to Friday in the AM time slot (8:30) and vice versa.
