## To Parents and Guardians:

The purpose of this letter is to inform you about a proposed optional field trip involving your child, and to seek your support and written permission for your child to participate.

We plan to finish off a fantastic year with our annual grade 8 trip to *Playland* on *Monday, June 22<sup>nd</sup>*, *2015.* Students are to arrive at Citadel for regular start time (8:40). Buses will depart Citadel at approximately **9:00am**, and leave Playland promptly at **1:45pm**, arriving back at Citadel just around dismissal time (2:50pm). We will require parent volunteers to help with supervision at Playland, and on the bus.

The cost for this field trip is \$32.00, which includes Playland entrance and bus fees. It does not include food or refreshments. Students are encouraged to bring a disposable bagged lunch. The cost for students who have a 'Season's Pass' for Playland is \$8.00 (bus charge only). Students using their Season's Pass must bring the pass with them on the day of the trip.

Our field trip to Playland will be a team-bonding experience to celebrate the end of grade 8... and middle school! Attendance on the field trip is optional; therefore if you do not wish your child to participate in this activity, alternate learning experiences will be provided at the school. The cost of the field trip reflects your child's expenses only. No student will be denied access to a field trip or activity due to an inability to pay. Please contact the school principal, Mrs. Speight, to discuss a fee waiver.

All students are expected to return to Citadel with the group on the buses.
