4. Principal's Report

Dave Phelan

- A staffing update was provided. We have two new teachers, four new EA's, a new Secretary, Youth Worker, and Counsellor. We have 9 divisions and 185 students so far.
- The previously announced playground should begin construction in October. This playground is designed for "primary" students (Kindergarten to Grade 2 aged).
 - This project has been funded through the insurance claim; however, this claim may be closed when it is time to move the structure back to Hazel Site. This means there is an approximate \$70,000 move cost which will need to be funded through other means. The PAC has agreed to hold specific fundraisers to aid in this expense.
 - Because of its age and location, "Red Slide" playground will more than likely be decommissioned during the school rebuild process and this new play structure will be in its place. Red Slide needs repair, at PAC cost, but it will not be necessary in this case as it would be replaced instead.
- There is nothing new regarding the Ministry. It was requested we as parents and a PAC continue to advocate for our school.
- The upcoming Pro-D day will be for teacher discussion on potential winter or spring shows by the students. More to come.
- Bus pickup at the new location appears to be working for the most part. Parents are once more reminded not to park on the street to the school nor to be on the roadway.
 - This year we only have one EA volunteer and one youth worker riding the buses with students leaving three out of four buses without additional supervision.
 - A reminder that the school code of conduct applies to students while on the bus.
 There have already been multiple reports of Bus A conduct issues and they are being dealt with on a case-by-case basis. If a student's behaviour reaches a certain point and all other disciplinary actions required have been taken, they can be prohibited from riding the bus and will be required to find alternate transportation for school.
- Volleyball stantions, nets, etc. are expected to arrive soon; however, it is too expensive to have the basketball nets lowered for elementary school height standards. It has been suggested that the school install elementary level basketball hoops in the outdoor space; it will be investigated for potential funding.
- Meet the teacher night is coming up this Thursday from 6-7pm; come from 5-6pm for a gym social and bring cash for the Grade 5 committee's snack and pizza concession.
- Upcoming dates include the September 30th Truth and Reconciliation Day as well as November 11th for Remembrance Day; the students will once again go to the Blue Mountain Park cenotaph for their ceremony.
- The Terry Fox run is upcoming and there is potential to bring students back to Hazel Site early so they can have their run around Settler's Park. Details to come, but that is our intent.

5. PAC Fundraising and Events

- Fundraising activities will look and feel different at Winslow Site than in previous years as we lost all of our items in the fire and currently have no way to store items at Winslow.
 - We are hoping this year we can encourage more family involvement in order to continue raising money for our school and students.
- The Welcome Back BBQ was replaced by the Grade 5 fundraiser in order to support our grade 5's ever increasing costs.
- We do not anticipate there being a Fun Fair this year. Castle Park Elementary, who let us use their site for ours last year, hold their own every two years and therefore cannot accommodate us this year.
 - We realize this is a tradition and important to students so are hoping pull something together in a similar format; this may mean an event at Winslow Site which, while not ideal, may be our best option. If you have any ideas or would like to help, please reach out to us, the sooner the better!
- Please check website regularly for specific fundraisers that do not have volunteer coordinators; without a coordinator, we cannot run them. We understand that this may sound like a daunting task, but there are many available to help if asked.

6. Treasurer's Report

8. Proposed Constitution & Bylaw Changes

- Three documents were provided to the members present: our current C&B from 2019, a redlined copy showing all changes being proposed, and a clean copy of the proposed document that, if adopted at next meeting, would be our new Constitution & Bylaws document. A link to these documents will be provided in our next newsletter for those who would like to review and provide feedback.
- Per Section 9 of our current C&B, the HTPAC Executive hereby provides the minimum required 14 days' notice (35 in actuality) to the Membership that we intend to update, amend, and/or alter our current Constitution and Bylaws.
- These proposed amendments will be voted on at the next General Meeting held in October and shall pass with the required 2/3'rds majority approval of the attending members; otherwise, the motion will fail, and we will discuss further.
- We request all interested Members to review the provided documents and provide their feedback, if any, to the PAC Executive via our email.
- Primarily, our proposed changes are focused on corrections of typos and grammar, improved readability, clarification of defined terms and rolls, and changes regarding digitization of HTPAC files as well as inclusive language when referencing the Members.
- More comprehensive changes within the document include a paragraph being moved from one section to another, an addition to Section 4 that reflects our intent of being an inclusive and non-biased PAC, an additional section regarding Fundraising, and the removal of a paragraph referencing a requirement of the School Law Act that no longer applies.
