## **Old Business**

#### **Breakfast Program**

Rob and Ursula and Christine met for next steps. The program last June was a pilot. While PAC members have been involved in co-ordinating the pilot, it is not an initiative of the PAC.

Here are the necessary next steps for it to proceed on an ongoing basis.

- 1. We need someone to come forward and volunteer to be the Co-ordinator to run with the program (not required to be a PAC person). It will need a volunteer team of 15-20 people to draw on 2 or 3 volunteers every morning that it operates. (About 40 kids per day were fed during the pilot.)
- 2. Need to get funding. Breakfast for Learning sent us the original funding by gift cards which we have not used yet. They need to be returned to Breakfast for Learning.

3. Work orders then need to be done for the upgrades (dishwasher, electrical, etc).

Rochester only does it a couple of mornings per week. There are options to run it only a few days per week but the bottom line is we need a volunteer Co-ordinator to run the program, whatever the scope ends up being. The PAC has lots of experience and information from the pilot they can provide to the Co-ordinator.

If nobody comes forward to co-ordinate, the program cannot run. If that is the case, the PAC will have to look at other options for helping address the problem of hungry kids in our school. For example, the PAC could help stock the fridge and office with food for kids who are hungry.

**ACTION:** Jennifer and Teri to draft a communication to send out to Parents (via Rob) asking for a Co-ordinator to come forward by January 13, 2015. Prospective Co-ordinators should contact Teri.

**ACTION:** Rob to Return funds to Breakfast for Learning.

## **Mad Science**
