Requirements:

- 1-The Canadian Iranian Foundation (CIF) is the administrator of the CIF Annual Scholarship.
- 2-Applicants must have legal Canadian status in Canada. Permanent resident or Canadian Citizen who reside in British Columbia.
- 3-Applicants must not be past recipients of the CIF scholarship.
- 4-Applicants must become a member of CIF before the interview process.
- 5-Applicants must be enrolled in a Canadian Post Secondary institution.
- 6-Applicants must provide a proof of enrolment letter from their post-secondary school.

7-Applicants must be well-rounded and demonstrate a good standing in art, leadership, humanitarian work, sports, and academics.

8-Applicants must have shown a great effort in trying to integrate into Canadian and Iranian society, by volunteering at least 20 hours of community service.

9-Applicants must volunteer for at least 20 hours at CIF events, in person before or after receiving their scholarship.

10-Applicants must provide one signed letter of reference supporting extra-curricular and volunteering activities in a sealed envelope.

11-Applicants must provide one signed letter of academic reference in a sealed envelope.

12- Applicants must provide the names of the two people who are providing him/her with the academic and community service letters of recommendation. These signed letters should be submitted with the application in a sealed envelope otherwise they will not be accepted.

13- Applicants should provide a head shot via e-mail.

14- Applicants must provide a 300-word essay about what sets them apart from others as an applicant.

15- Applicants must mail the completed application and the enclosed requirements to the Canadian Iranian Foundation's mailing address: P.O. Box 91231 West Vancouver, BC. V7V 3N6 or E-mail to info@cif-bc.com with a head shot before midnight on June 15th. 2024.

16- Incomplete applications and applications received after June 15th. 2024, will not be considered for scholarship.

17- Successful applicants will be asked to partake in an interview in person.

18- Successful applicants will be informed via e-mail about the time and date of the interview.

19- Successful applicants will be informed about the outcome of their interview via e-mail and a letter.

20- Scholarship recipients must be present at the award ceremony in person.
