

# AGREEMENT

TO BE READ AND SIGNED BY BOTH PARENT AND STUDENT

I, the undersigned, an applicant for a travel/study program of Pacific Student Educational Adventures, in consideration of my acceptance for participation in such program, do waive and release all claims, demands or causes of action against PacSEA\* and its agents, and my local school for any illness, injury, loss, damage, accident, delay or expense resulting from the use of any vehicle, any strikes, war, weather, sickness, quarantine, government restrictions or regulations arising from any act or omission of any airline, railroad, bus company, hotel, or individual. I also release PacSEA and its agents and agree to indemnify them with regard to any financial obligations or liabilities that I may personally incur or any damage or injury to the person or property of others that I may cause, while participating in a PacSEA program. No responsibility is incurred by PacSEA or its agents for loss of airline tickets or other travel documents, loss or damage to luggage or any other participant's belongings or for consequential damages.

I hereby grant PacSEA and its agents full authority to take whatever actions they may consider to be warranted under circumstances regarding my health and safety, and I fully release them from any liability for such decisions or actions as may be taken in connection therewith. I authorize PacSEA and its agents at their discretion, to place me, without my further consent, in a hospital within or outside the United States for medical services and treatment or, if no hospital is readily available, to place me in the hands of a local medical doctor for treatment. I authorize PacSEA and its agents to purchase, on my behalf, a comprehensive extended medical and cancellation insurance policy for the duration of the program.

I understand that this is a supervised program and that group standards must be observed. I will at all times remain under the supervision of the group leader. I hereby waive and release all claims against PacSEA and its agents arising out of my failure to remain under such supervision or to comply with expected rules, standards, and instructions. I consent to being sent home without refund at my own (or my parents') expense subject to review of the teacher, PacSEA, and its agents should I fail to comply with the above.

I certify that I have read the terms and conditions of this agreement and I understand that this agreement will be effective only upon my acceptance by PacSEA as a participant in one of its programs.

## CANCELLATION/REFUND POLICY

Pacific Student Educational Adventures makes substantial advance deposits to airlines, hotels, and bus companies. Because these deposits are non-refundable to PacSEA, program participants canceling their trips are subject to the following terms and conditions:

### If a Participant Cancels:

### PacSEA Refunds All Payment, Less ...

91 to 120 days	Before Departure	\$100 USD
61 to 90 days	Before Departure	\$250 USD
0 to 60 days	Before Departure	non-refundable

All cancellations must be made in writing. A participant who cancels, but finds a replacement for the program fewer than 60 days before departure, will receive a full refund less a \$75 handling fee.
