2a. Principal's Report

• Ms Tipper spoke about enrollment and staffing for the 2014-15 school year. Enrollment looks to be the same; a big group of Kindergarten students are coming in (40), and 37 grade 5s are leaving.

- Staffing allotment will be coming in May.
- The Budget for 2014-15 includes many proposed cuts to deal with a \$13.5 million deficit in SD 43. The Board of Education is considering all possibilities and decisions will be made soon. Cuts may affect teaching staff positions, library services, cafeteria services (where applicable), support staff, school bus services (where applicable), and so on. The Budget is on the school website and Ms Tipper is always open to parents' questions and comments.

2b. Treasurer's Report

- The Evening Market numbers are in and it was a great success as a fundraiser for the modest cost that went in to it. Profit was roughly \$1100. Again, thanks to Nagisa Inoue for spearheading this event.
- The recent Movie Night showing "Frozen" raised \$700.
- The Gaming Grant application will be submitted by June 30th for the next school year.
- \$1500 has been used from the Gaming Account so far this year. Hip Hop Lessons are yet to be deducted. We're on track to have a surplus of \$2000 going in to next year.
- We discussed allowing teachers to access more fees from the PAC for more expensive field trips (in addition to the \$5 per student that PAC planned on for this school year). This may cause some confusion and/or unfairness, or even upset our budget plans. We decided to leave the plan as is and discuss any changes for next year at a later meeting.

2c. Hot Lunch Coordinator

Lindsay is planning the next Pizza Day for May 8th.

2d. Fundraising

Ice Cream Truck Presenter: Bev Komukai

 We have the opportunity to have the Rocky Point Ice Cream Truck come to our school. 50 cents from every item sold would go back to the PAC. We discussed having it come to our Spirit Day, perhaps between 11 and 3. Bev will contact them again to see if June 13 is available. Value Village Presenter: Lindsay MacPherson

Miscellaneous Presenter: Greg Ryley

- Greg mentioned the success of the \$5 Emergency Supplies fee and wondered if we could ask parents for a \$5 play ground improvement fee, instead of traditional fundraising like selling poinsettias or gift cards, etc. This type of direct appeal lets parents know specifically what we are raising money for.
- Currently, the PAC Meeting Highlights state how much profit we make and what it's intended for, but we could have a clearer financial plan at the beginning of the school year.
- We'll continue to look at how we approach fundraising for next year.
